### Project abstract:

Alaric has often been seen as the leader of the Visigothic people, from 395 to his death in 410. Before his rebellion against the Roman Empire in 395, he served in the Roman military, participating in the campaign against Eugenius and Arbogast in 394. His early career is mentioned in the work of the historian Zosimus. But his background is shrouded in mystery. In the middle of the 6th century, Jordanes wrote about his noble origin and the Visigothic dynasty of Balthi. This has led some historians to look for Alaric's origins among the chieftains and nobility of the Gothic tribe of the Thervingi. Among contemporary authors, only the verses of the poet Claudian mention Alaric's birth. This article explores the possibilities of Alaric's origin and the internal policies of the Goths living in Roman territory. Most likely, the person of Alaric was more closely associated with the Roman army than is usually thought

## Data Collection

### What data will you collect or create?

The collected data will be critical editions of late antique textual sources from the late fourth century and early fifth century. These editions are uploaded on online sources series Monumenta Germaniae Historica ([Die MGH | mgh.de](http://www.mgh.de)) or are available in print in university libraries across Europe. No new data materials or datasets will be created. The research will be based on the analysis and comparison of existing and processed text data.

### How will the data be collected or created?

Data and materials will be collected by reading textual sources. As they are read and analyzed, handwritten notes will be created for further research purposes. Materials will be borrowed from libraries in the Czech Republic, from texts available online and from texts lent by the International Library Lending Service and from materials in the author's personal possession. No new data will be generated in this research.

No additional documentation and metadata will be created in this particular research.

## Ethics and Legal Compliance

### How will you manage any ethical issues?

The ethical issues in this research will be handled by consistent and responsible citation according to the Chicago Manual of Style. Other ethical issues are not relevant to this research.
