### Project abstract:

Slovak doctor Silvester Krčméry together with Vladimír Jukle, founded a secret church in Slovakia during the communist era. For this and his other activities against the communist regime, Krčméry was imprisoned for 13 years, from 1951 to 1964. Silvester Krčméry, a man who played a significant role in the history of Slovakia, wrote in his biography, that his grandparents were representatives of four different nations, his grandfathers were Slovak and Polish, and his grandmothers were Hungarian and Armenian, respectively. Krčméry's Armenian grandmother, Anna (Netti) Zakharias, was a noblewoman from Transylvania, and the wife of Karol Krčméry, a long-time Latin teacher at Armenian gymnasium in Transylvanian Elisabetopolis, well-known linguist, Slovak and Czechoslovak politician and interwar senator of the National Assembly. The events dedicated to the 100th anniversary of Silvester Krčméry, also arouse interest in Krčméry's Armenian roots and character, as well as the history of Armenians in Transylvania.

## Data Collection

### What data will you collect or create?

The data collected for this research consists of archival documents, memoirs and secondary literature on Transylvanian Armenians, as well as research data on their genealogy.

### How will the data be collected or created?

All the data will be collected from the archives, libraries and on-line resources. Krčméry's family archive will also be used for comparison and analysis. For the data collection a visit to Budapest and several meetings with Armenologists and prominent Armenians are planned there. Rich material of 'Orer' Armenian European Magazine (co-founded by me) on Transylvanian Armenians, (i.e. Armenians in Hungary, Romania, Western Ukraine) will also be used. A new family tree will be drawn as new data on Silvester Krčméry's ancestors.

No additional documentation and/or metadata will be created in this research.
